- Patch Set Holders who no longer wish to be active in the ministry must turn in Patch Sets to their Chapter President or to CRMM International, P.O. Box 543, Galliano, LA 70354. Any member who refuses to turn in his/her Patch Set when requested by an authorized officer of CRMM will face fines up to \$500 and/or court costs to recover patch sets.
- Any member who violates the By-laws and Guidelines of CRMM must turn in his/her patch set to the Chapter President until such time as they are reinstated into full fellowship in the ministry. Any member who refuses to turn in his/her Patch Set when requested by an authorized officer of CRMM will face fines up to \$500 and/or court costs to recover patch sets.

### **CRMM Membership Application and Patch Guidelines as of June 27, 2010**

- At the first meeting – complete pre-application for contact information only.
- After 3 months if interested in joining as associate member – complete CRMM Associate Application.
- After 3 more months – if qualified can apply for and wear 100% patch on a vest.  
**CRMM Patch Sets consist of Top Rocker, Eagle Wings, Bottom Rocker and MM**
- After 6 more months – if qualified can apply for Eagle Wings and Bottom Rocker to wear on vest.
- After 7 more months – if qualified can apply for Top Rocker and MM to wear on vest.

**I agree to abide by the Rules and Regulations for Patch Set Holders as stated in the By-laws and Guidelines of CRMM. Rules include but are not limited to the following:**

- Members may request 1-3 sets and Chapter Presidents and Senior Presidents can request as many as needed to operate the chapter.
- Patch Set Holders must be faithful, active members of CRMM and attending church members.
- Patch Set Holders must not give and/or sell their Patch Set to any other person. Patch Set Holders may request that their patches be given to another member, but the Chapter President will make the determination as to whether or not this member is eligible to receive the patch set.
- Members wearing patches must always have another member accompany them when witnessing at/or attending secular events in places where there is liquor served or activities taking place that are not in line with Christian principals (i.e. barrooms, poker runs, etc.)
- An officer wearing Colors may enter a questionable establishment alone in order to give assistance to a brother or sister who may be in danger of falling into sin.
- Members wearing Colors represent CRMM and must always be a good example of Christian Witness.
